Pledge of Allegiance: Everyone stood for the Pledge of Allegiance.

Board Quorum: Secretary Van Ness verified that a Board Quorum was present.

President Comments: President Hoffer explained the process for a Regular Board Meeting and how the Board conducts business. He introduced the Directors and members of the Management team.

Minutes: On Motion by Director Wieland and seconded by Vice President DeLano, the Minutes of the January 26, 2017 Regular Board Meeting were unanimously approved.

Committee Reports: The Directors reported on Committees as follows:

Ad Hoc Long Range Planning: Chair Rich Hoffer reported that The Ad Hoc Long Range Planning Committee last met on February 10, 2017. The Town Hall Meetings were well attended and many suggestions were given for the property. The Committee eliminated the ideas they did not feel had merit. The Committee is meeting again this month to discuss additional information prior to interviewing the remaining Clubs interested in space, at the Grand Ave Property, in hopes to get the list of Candidates down to six (6).
