**GENERAL INFORMATION:**

Both Lakeview East and West have had plinth boards adjusted to a consistent elevation and are scheduled to be deep-tine aerated this week. During the month of June we will undertake frazing and verticutting as well as laser-leveling of both greens.

Bell North was core aerated and sand topdressed this morning (Tuesday) Bell South will be core aerated/topdressed next Tuesday, May 23rd. Both bell greens were verticut last month.

Mountain View is scheduled to be core aerated/topdressed on Friday, May 19th and verticut on Wednesday, May 24th.

Oakmont is scheduled to be verticut on Thursday, May 18th and core aerated/topdressed on Tuesday, May 30th.

**New Business:**

The Committee discussed the conditions of the greens.

A request was made to change Oakmont's watering and cutting schedule due to Lakeview now using greens during the closure of the Lakeview greens.

Plinth boards at Lakeview have been laser leveled.

Canopy and benches have been ordered for Bell.

Discussion on the 2018 U.S. Open was had and that approval from RCSC is needed for tournament.
