- With the cooler night-time temperatures, we have reduced irrigation on all greens.

GENERAL INFORMATION:

- Lakeview east green opened for play yesterday, Monday, November 6. This green will be mowed Wednesday, November 8 with the “Fat Boy” to help smooth the surface and then lightly sand topdressed. Both west and east greens will continue to be mowed and rolled every other day.
- Both Bell north and south greens had an application of granular fertilizer and were mowed with the “Fat Boy” to help smooth the surface.
- Oakmont received an application of granular fertilizer.
- We cut out and re-sodded the bad areas on Mountain View green last Friday, November 3. These sodded areas will need additional hand watering to heal over the next 2 weeks and will remain flagged to keep traffic off.

Discussion:

The loss of the Lakeview green has resulted in 47 venue changes of previously scheduled events and tournament dates. Concern was expressed for how the east green at Lakeview will hold up under the use it will receive this season.

Committee inquired if the frazing contract had been signed for the Bell project.
