- Our crew will aerate all lawn bowl greens this week using ¼” needle-tines. This will help open up the surface allowing air and water to penetrate.
- In addition to the aeration, we will also be verticutting all greens 2 directions beginning next week.
- We have set up a meeting with all parties that will be involved with the Bell project for Monday, April 2nd. This includes D. Lyall Adams, Turf Equipment Source and Evergreen Turf.
- We continue to mow 1 x per week and roll 4 x per week on average. Lakeview is currently being mowed at .110”.

- Dennis to get dates of greens maintenance so green closing can be accomplished.
