## Golf Advisory Committee February 15, 2024

Chair Steve Collins called the meeting to order at 8:30am in the Lakeview Social Hall #2.

**Review/Amend Prior Meeting Summary:** The Summary from the January 18, 2024 was amended to reverse the statements made under Ladies 9 and Ladies 18. The Summary was accepted as amended.

## **Brian Duthu, Director of Golf Report:**

#### **Pro Shops**

We played 36,483 rounds in January, an increase of 588 over prior year, of those 19,315 were played by Annual No Fee (Resident) and Annual Surcharge passholders. Remaining rounds were played by Cardholder Daily (7,198), Cardholder Guest (3,855), RCSC Staff (785), Non-Resident passholder (1,301) and Public (4,014). Total rounds were 588 greater than the previous year. Despite the rounds increase preliminary revenue shows Green Fee/Cart Fee revenue missing budget by \$51,199 and exceeding prior year by \$16,964. Merchandise missed budget by \$9,959. Driving Range revenue also missed budget by \$8,315. Revenue was impacted by a decrease of 623 Public Rounds and 213 Guest Rounds, the biggest gain in rounds were No Fee (708) and Cardholder Daily (592).

The bump rate (those golfers requesting a tee time through the lottery that were unsuccessful), for January had similar results to December. Overall, we had an increase in the number of requests of 9.36% (17,282 in 2023 versus 18,899 in 2024), however the number of golfers bumped dropped by 3.45% (1,837 in 2023 versus 1,357 in 2024). Overall, our bump rate was 7.18% for the month.

Free golf clinics will be offered March 9, 16, 23 & 30, at Lakes East/Lakes West, classes begin at 9:30 am. Topics covered are ball flight, golf swing fundamentals, chipping and putting. There is no need to pre-register, and the clinics are open to golfers of all skill levels. The clinics are a great introduction to the game of golf or a great way to brush up on your game. Clinics are conducted by PGA and LPGA professionals.

#### **Snack Shops**

Snack shops' closing time is 5:00 pm. and will remain so until rounds begin decreasing in April. Snack Shops have the discretion to remain open longer on particularly busy days.

#### **Golf Courses**

The preliminary aerification/overseed schedule presented to Golf Advisory in January, was also presented to each course's Green Committee. We did receive minor requests for adjustments, the adjustments are reflected in the schedule that is attached. The schedule can also be found on the RCSC website.

As we move into spring we can expect an increase in golf rounds, with increased rounds come increased wear and tear. As temperatures warm throughout the spring, these wear and tear areas will heal faster, however we still need golfer support. We ask everyone to please fill your divots and fix your ball marks. With increased play slow play instances become more likely. We ask everyone to please practice ready golf by; playing your shot as soon as possible and when it doesn't interfere with your playing partners or the group ahead, move to your ball whenever it is safe to do so, avoid excessive practice swings, read your putt ahead of your turn and record scores on the following tee box.

### **SCWGA Report:**

**Ladies 18-Hole:** They just completed a successful Sun City open tournament. Many thanks to the courses that have stepped up to help with future tournaments.

Ladies 9-Hole: Currently working on upcoming tournaments.

#### **Old Business:**

A handout of Golf Input to RCSC 5-Year Strategic Plan was presented and discussed. Direction was given to review again with applicable Greens Committee's and provide input and/or comments to the Golf Sr. Leader Brian Duthu for further discussion at our next meeting. The intent is to have all input consolidated and prepared for the next budget cycle.

Co-Chair Kise made a motion "I move to amend Board Policy 17 titled Golf, Section titled General Golf Rules & Regulations by striking paragraphs 2, 3, 4, 5, 6, 7, and 9. These Items will be under the authority of the Director of Golf. Motion seconded after much discussion the question was called and the motion approved by a vote of 18 for and 1 against. Motion passed and will be referred to the RCSC Board of Directors for approval.

#### **New Business:**

A change to the meeting day was suggested and agreed upon starting in April 2024. The meetings will be held on the Second Thursday of each month rather than the third and will be held at the same place and time.

**Comments:** Several guests in attendance made comments listed below.

- There needs to be better communication with the general golfing members.
- The general golfing members need to have representation on the Golf Advisory Committee.
- The Lottery does not handle multiple group requests well. i.e. more than 3 tee times requested.
- Need to return to split sheets to make more time available in the early slots.
- No shows, and requests for more slots than needed i.e. request 5 and use less, need to be controlled and or eliminated.
- No singles or twosomes allowed during heavy schedules.
- Pace of play needs better control.
- How do I find out about available playing groups?
- Courses are inconsistent in playability.
- Do away with 5-some's.
- To help speed up play when riding with another person while that person is hitting walk to your golf ball and get ready to hit.
- Play ready golf.
- Players need to follow the general rules of golf and golf etiquette.

#### **Course Reports:**

North Course is coming along. Back 9 is dormant and dry. Next year will be better.

South Very good shape. Greens are still a little slow 8.8 on the stimpmeter.

Quail Run No Report

Lakes West Great shape greens are speedy.

Lakes East No complaints good shape.

Riverview Happy with the course condition. Tournaments went well.

Willowcreek/Willowbrook: Both courses are reaping the benefits of coming out of a good overseed and the courses are in great shape.

Willow Brook: See above.

Diane Hull representative of Lakes West presented a handout on proper raking of bunkers and placement of the rake after raking. These will be displayed at the courses.
