# RECREATION CENTERS OF SUN CITY, INC. (RCSC) FEES

### **Annual Property Assessment Fee**

### \*\$575 per year/per property (effective 1/1/2024)

The Facilities Agreement, executed by each Deeded Real Estate Owner in Sun City AZ, obligates Owners to pay annual property assessments to the RCSC whether or not Owners occupy the Sun City AZ property or use RCSC facilities. Failure to pay these fees by the due date will render any RCSC cards issued for the Sun City AZ property no longer valid and the respective cardholders no longer eligible to use RCSC facilities or participate in Sun City AZ clubs.

## **Preservation & Improvement Fee**

### \*\$4,000 per occurrence

A Preservation and Improvement Fee shall be imposed on the purchase, acquisition, transfer, inheritance, gift or any change in ownership of legal or beneficial interest in the title to property located in Sun City, Arizona pursuant to any deed, contract for sale, will or other instrument or document transferring an interest in such property, so long as the original payer of said Preservation and Improvement Fee no longer retains a majority ownership interest in the property.

# Capital Improvement Fee (for closings starting Jan 2024) \*\$1,000 per occurrence

A Capital Improvement Fee shall be imposed on the purchase, acquisition, transfer, inheritance, gift or any change in ownership of legal or beneficial interest in the title to property located in Sun City, Arizona pursuant to any deed, contract for sale, will or other instrument or document transferring an interest in such property, so long as the original payer of said Preservation and Improvement Fee no longer retains a majority ownership interest in the property.

### **Transfer Fee**

# \*\$300 per occurrence

A Transfer Fee shall be imposed on the purchase, acquisition, transfer, inheritance, gift or any change inownership of legal or beneficial interest in the title to property located in Sun City, Arizona pursuant to any deed, contract for sale, will or other instrument or document transferring an interest in such property, so long as the original payer of said Transfer Fee no longer retains a majority ownership interest in the property.

### **Recording Fee**

### \*\$30 per occurrence

A Recording Fee shall be imposed on the purchase, acquisition, transfer, inheritance, gift or any change in ownership of legal or beneficial interest in the title to property located in Sun City, Arizona pursuant to any deed, contract for sale, will or other instrument or document transferring an interest in such property.

#### **RCSC Member Cards**

Up to Two (2) Member Cards may be provided for each property, provided there are two persons who meet the qualifications of Article II of RCSC's Corporate Bylaws (<a href="http://suncityaz.org/corporate-bylaws/">http://suncityaz.org/corporate-bylaws/</a>). A Member must be a Deeded Real Estate Owner of property in Sun City AZ; must be 55 years of age or older or meet the spousal exemption requirement; and must occupy the Sun City property as their primary Arizona residence unless their other Arizona residence is farther than 75 miles from Sun City AZ.

# **RCSC Annual Privilege Card**

\*\$287.50 per person/per year (effective 1/1/2024)

### Short-term Privilege Card (30-60-90 days)

### \*\$75 per person/per month

A Non-Owner of a property in Sun City AZ may be issued an annual Privilege Card for a fee provided: at least one Owner or Non-Owner who occupies the property is 55 years of age or older; the Non-Owner occupies the Sun City AZ property as his/her primary Arizona residence unless his/her other Arizona residence is farther than seventy-five (75) miles from Sun City AZ in which case the Non-Owner(s) must provide proof that he/she occupies the Sun City AZ residence as well; the Non-Owner is not under 19 years of age, and; the property assessments and fees, where such Non-Owner resides, are current.
