### **\*Use of Recreation Center of Sun City (RCSC) Facilities**

If eligible, you may purchase an RCSC Privilege Card which enables you to use most of the Recreation Center of Sun City (RCSC) facilities at no charge (clubs generally charge a small fee) and will allow you to golf and bowl at reduced cardholder rates. Please see the following information on the eligibility for and cost of a Recreation Centers of Sun City Privilege Card:

<b>Short-term Privilege Card (30-60-90 days)</b>	<b>\$75 per person/per month</b>
<b>Annual Privilege Card</b>	<b>\$287.50 per person</b>

#### **\*Fees subject to change**

A Non-Owner of a property in Sun City AZ may be issued an annual Privilege Card for a fee provided: at least one Owner or Non-Owner who occupies the property is 55 years of age or older; the Non-Owner occupies the Sun City AZ property as his/her primary Arizona residence unless his/her other residence is farther than seventy-five (75) miles from Sun City AZ, in which case the Non-Owner(s) must provide proof that he/she occupies the Sun City AZ residence as well; the Non-Owner is not under 19 years of age, and; the property assessments and fees, where such Non-Owner resides, are current.



## Important 85373 Zip Code Information

A - The upper area of the 85373 zip code (north of Bell Road) has the Sun City name because their mail is distributed through the Sun City Post Office.

A - Homes in this area (north of Union Hills, north of Beardsley) are either in the City of Peoria or unincorporated Maricopa County. They are NOT part of the Sun City AZ community.

A - Residences in this area DO NOT have access to Recreation Centers of Sun City, Inc. (RCSC) facilities, events or activities in Sun City AZ.

B - Residences in this area DO have access to RCSC facilities, events and activities in Sun City AZ.
