Along with the Bowling for Veterans Link (BVL) and Sun City Bowling Association (SCBA) events, Lakeview Lanes also hosted 'Bowling for Boxers' in the name of late Sun City resident Glenn Coyle. The event was a huge success, drawing a total of 91 bowlers. Through generous donations by the participants, over \$1,800 was raised for the Boxer Luv Rescue organization.

There were several honor scores earned by our league bowlers since the last committee meeting. Eleven '300-games' and three '800-series' were bowled at our centers since December 5, 2024.

Effective today (January 2, 2025), the lineage for open bowling has increased to \$2.90 per game for RCSC members and \$3.75 per game for guests. League rates will not be affected until the conclusion of the current season.

On January 11^{th} , Lakeview Lanes hosts the 12^{th} Annual Bowling Over Cancer event, which has already received the maximum number of entries.

On January 18th and 19th, the 2025 TAT Masters Special Event will debut at Lakeview Lanes. The Bell Lanes No-Tap Tournament Series begins its 2025 slate on January 26th with a Scotch Doubles event. The tournament currently has 60 teams (120 bowlers) signed up to compete.
