Instructions

- 3. If all information cannot fit on the form, please indicate on the form "see attached" and attach any documents necessary.
- 4. When the form is complete, submit it to the RCSC Clubs Office, Oakmont Center, 10725 W Oakmont Dr (623-561-4660); email clubs@suncityaz.org.
- 5. Clubs office will review the form and if complete, the request will be delivered to the Board Office.
- 6. After review by the RCSC Board, you will receive notification from the Board Office as to whether your request was approved or denied.
