Approval of Prior Meeting Summary: The September 12, 2018 Meeting Summary was approved as presented.

Report by Myrna DeBruyne, Member Services Coordinator: Distributed to the Committee for review and reads:

We have received 103 Club Membership Rosters and 66 of those Membership Rosters have been processed. Approximately 85% of the rosters received have been in the correct format.
