Approval of Prior Meeting Summary: The May 10, 2023 Meeting Summary was approved as presented.

Report Joanne Martin, Chartered Club Supervisor: Director of Operations Chris Herring reported in Joanne Martins absence:

- Water Volleyball extension of club hours to include the 11:00am-12:00pm hour on Monday, Wednesday, Friday, Sunday. For the summer months additional time on Tuesday and Thursday evenings from 5:30pm-8:00pm has been added. The evening hours will go through Labor Day.
- Table Tennis Extension of club hours to include the 9:00am-10:00am hour on Monday, Tuesday, Wednesday, Friday.
- Wallyball Working to have the net mounts installed at the racquetball courts. Previous attempts to use suction mounted brackets were not successful.
- Oakmont Center Closure Highlighted the closure of the Oakmont Center from 6/26 through 7/9 for reroofing of the entire center.
- Club Budget Requests noted that these were due as of 6/1 and are being consolidated and evaluated.

Chair Report: Chair Collins stated that there are issues concerning chronic memberships in "like-kind" clubs. The problems arise where a member is written up for some type of bad behavior, suspended for a certain period of time in one club, then joins another similar club, and continues the bad behavior. There has been no way of tracking these offenders in the past. There needs to be some type of system created between the clubs, COC and the RCSC to fix this problem. A robust and lengthy conversation took place concerning previous and potential situations concerning profanity, touching and threat incidents between individuals and the club's Board members.

It was decided that the procedures, guidelines, suspensions and punishments need to be updated. COCs, over the summer, will meet to create a flow chart for procedures in

handling serial offenders for presentation at the September meeting.
