Review/Amend Prior Meeting Summary: The February 14, 2024 Meeting Summary was accepted as presented.

Report Angella Willette, Chartered Club Supervisor: Distributed to the Committee for review.

 - The Apple Macintosh Club has requested to merge with the Computer Club of Sun City. If approved, they will relocate to the computer club room at the Fairway Center.

COC Reports:

- Pickleball working on a rules & regulation change regarding fees.
- Water Volleyball group working on rules & regulations regarding robust vs friendly play.
- Tai Chi had some Board resignations, and the position of President needs to be filled.
- Lakeview woodshop working on a member becoming a vendor that has a lumbermill.

Old Business:

Bell Crafters report discussed safe storage for club records. Some suggestions were using locked file cabinets in the club room, renting safety deposit boxes or mailboxes and trusting the club treasurer to keep sensitive records safe and secure.

New Business:
