Chair Richtmyre will provide a brief announcement at the October 31st RCSC Board meeting to encourage members to come and watch the US Lawn Bowling Open November 3rd through the 9th. Hopefully, Norm can complete the presentation in time for the November committee meeting for recommendation to the Board to be voted on at the November Board meeting.

The benches at Bell are better since the painting. Michael commented that the sprinklers for watering the greens are causing hard water marks on the benches. Everyone is happy with the painted benches.

Michael will compile the previous four years of lawn bowling membership and usage. He will also create a projection of lawn bowling membership of when membership will reach the 500-membership mark.

No decision has been made by RCSC Management and the Board regarding the placement of the Performing Arts Center (PAC).

New Business:

The Committee discussed the Lakeview line markers. Jim and Michael will look into contacting Bell Metal for assistance in sandblasting the existing metal markers, and possibly powder coating them in time for the US Open.

The President of the US Lawn Bowling Association will be in town soon in preparation of the event.

Discussion by Board members Fimmel, Richtmyre and Board President Foster determined that it would be months down the road before a decision could be made due to the timeframe of the Mountainview and Performing Arts Center (PAC) design timelines.
